In the mean time you will instantly withdraw your peons from that Country after the receipt of this order which you will consider to be positive.

It is altogether repugnant to your duty and allegiance to employ any military force without my express authority for any purpose whatever except the interior regulation of your own districts and if I find on enquiry that the facts above stated have been correctly represented I shall certainly signify the most decided marks of my displeasure.

In the meantime you will instantly withdraw your peons from that country after the receipt of this order which you will consider as positive.

After Compliments.

Since the commencement of my friendship with the Sirdars of the Honorable Company I have been deeply impressed with the characteristic sincerity of the Company beyond that of their predecessors or Cotemporaries: nay, from the beginning I was convinced that my wishes and prayers to the Almighty would be successful and that the following sentiments "heart should unite with Heart", would be Exemplified by all the Sirdars of the Company, and particularly by your Lordship who is vested with plenary powers for the administration of this Country therefore notwithstanding the occurrence of late circumstances, and with a view to strengthen the bonds of friendship, I have deputed Mir Gholam Ali Saheb, who is Eminent amongst people of rank for his worth, wisdom, and Capacity to be the personal Channel of communication thro which the mutual accounts of our welfare, may be constantly transmitted according to former custom.

It is worthy of your beneficence to delight me by the friendly communication of a kind answer, and that henceforth in opposition to former practice, you will gratify and oblige me by the transmission thro the said person of letters Expressive of your esteem you should consider me as one, who in the sincerity of his attachment to the Company has no superior.

TO MEER KUMMER UL DEEN KHAN &C<sup>a</sup> &C<sup>a</sup> &C<sup>a</sup>

I have received your friendly letter dated the 18<sup>th</sup> December last expressive of your regard and attachment to the English Company's Government, and proposing that Meer Gholaum Ali should reside here on your part as a medium of communication between you and this Government and have understood its contents.

The assurances of your respect and attachment to the English nation are very acceptable, and should be happy on all occasions to make every return to conduct founded on these sentiments which is consistent with our relative Situations.

But it can not be unknown to a Chief of your experience that according to the customs and law of nations public envoys and ambassadors are sent by independent powers only to reside at each others Courts and that the act of receiving and accrediting an envoy from a dependant Chief is in itself a disrespect to the power on whom he depends, and subversive of his paramount authority.

And as by the favour of the Almighty the most perfect friendship subsists between the English Company and the Court of your superior the Nizam of the Decan, You will perceive that I am influenced not less by a sence of propriety towards that Court than by an attention to your own credit and interests in directing that Meer Gholaum Ali should receive his permission to return to Goorumeonda.

### No. 7.

TRANSLATION OF A LETTER FROM THE POLIGAR OF BOM RAJ PALAH TO THE  
RIGHT HONORABLE LORD CLIVE, &C<sup>a</sup> &C<sup>a</sup> &C<sup>a</sup>

DATED 11<sup>TH</sup> AUGUST } 1800.  
RECEIVED 13<sup>TH</sup> D<sup>o</sup>

I had the honor to receive your Lordship's Enayit Namah dated the 28<sup>th</sup> July, informing me that (the letter of the 28<sup>th</sup> July have recapitulated) and I understood the contents.

My Lord ! my peons are employed in tilling their Cuttabadi or their inaam lands and I have no power to assemble them without your Lordship's orders, much less to detach them, and to sanction oppression and violence in the country farther without authority.

My Lord ! my Peons have not hitherto been detached nor shall they be so hereafter.

The situation of affairs here is as follows :—

Vencataram Raj the Elder Son of the Mutlawar Rajah had, for a series of years administered the affairs of that talukah ; But Asud Ali Chan the former Chief of the Subah of Corpah, in consequence some misunderstanding displaced him, and appointed Vencat Raghoe Raj, the brother of the 2<sup>d</sup> Rajah, to the talukah in his room.

At present the Foug dare here, Chendia Lal having expelled Vencat Ragho Raj, and placed a Sirkars Garrison in the place, has sent for Vencat Ram Raj to reinstate him in the Talukah and the Regulation for the Peisheush is on foot. But it has been the officers (functionaries) of the Sirkar who have made Vencat Ragho Raj to retire; Vencat Ram Rag has not opposed, nor Pursued him:—I have not however sent any assistance to the 2<sup>d</sup> Rajah nor shall I do it without your Lordships orders. I am in every respect, and on every occasion, attached to the interests of your Lordship and the Honourable Company and hopeful of meeting with their favour and indulgence accordingly.

In any event I hope that your Lordship's Protection and Countenance will alloways be afforded to me.

What more should I intrude.

May it please Your Highness

I have the honour to inform your Highness that Rajah Ragotum Row, one of the principal ministers of His Highness the Nabob Nizam ul doulah Asoph Jah Bahadur having obtained His Highness's permission to make a pilgrimage to Tripetty, departed from Hyderabad for that purpose on the first day of this month.

The Rank which the Rajah Ragotum Row holds at the Court of Nizam ud Doulah entitles him to every degree of attention from the British Government and its allies; I beg leave therefore to recommend him to the distinguished notice of your Highness during the time he may be a guest within your Highness's dominions.

I have the honour to enclose a memorandum of the requests made to the British Resident at Hyderabad by Rajah Ragotum Row together with a memorandum of the attendants who wait on the Rajah and beg that your Highness will cause positive orders to be issued to the Aumil of Tripetty for complying with the wishes of the Rajah.

In addition to the points stated in the Memorandum I am extremely desirous that Rajah Ragotum Row and his attendants should be exempted entirely from the usual duties and taxes paid by the Pilgrims at Tripetty; and I shall have great pleasure in accounting to your Highness for the amount of the duties, which may be so remitted, in the account of your Highness's current Kists.

In compliance with the request of Rajah Ragotum Row it is my intention to depute a gentleman to attend him on the part of the British Government during his residence at Tripetty; and have selected Rajah Sree Mysoor Tremulrow to perform these duties of hospitality; I have therefore the honor farther to request that your Highness will direct the Aumil to comply with all applications which may be made to him by Rajah Sree Mysoor Tremulrow for the accomodation of Rajah Ragotum Row.

I beg leave to add that in the present state of the alliance between the British Government and His Highness the Nabob Asoph Jah, it is my earnest desire that no deficiency should occur in the attentions and respect which I propose to pay to His Highness's minister Rajah Ragotum Row; and I therefore request that your Highness's orders may be framed in conformity to this anxiety.

TRANSLATION OF A LETTER FROM HIS HIGHNESS THE NABOB OF THE CARNATIC TO  
THE RIGHT HONORABLE LORD CLIVE &C<sup>A</sup> &C<sup>A</sup> &C<sup>A</sup>

DATED 10<sup>TH</sup> SEPTEMBER } 1800.

I have received your Lordship's Letter of the 9<sup>th</sup> Instant upon the subject of the departure of Rajah Ragotum Row (one of the principal officers of the Nabob Asof Jah Bahaudur) on a pilgrimage to Tripatti—the necessity of shewing him every respectful and honorable attention—requesting accordingly, that I would issue orders to my Â'umil at Tripatti to conform to the wishes of the said Rajah—and to exempt him from the usual duties levied from pilgrims at Tripatti the amount of which exemption I should be allowed credit for in my Kists, also enclosing two papers of memoranda, one of the requests made by the said Rajah, and the other of the followers, &c<sup>a</sup>, in his Suite — and I have understood the contents.

On the 8<sup>th</sup> instant when first I was apprized of the Journey of the said Rajah, I immediately wrote to the Â'amils of Ongole Nellore &c<sup>a</sup>. directing them to perform the duties of hospitality to furnish the necessary supplies and to exempt him from the payment of duties; as soon as I received your Lordship's Letter I repeated the above orders and also transmitted the strongest injunctions to the Â'amil of Tripatti directing him to meet the Rajah and to treat him with the utmost Civility and respect, to allot a suitable habitation for him, to exempt him entirely from the duties and to attend to all his wishes. I enclose for your Lordship's information a Copy of the letter to the Â'amil of Tripatti, and I request that your Lordship will be pleased to inform me, if I have omitted any point of the Rajah's requests; in which case, I shall with the utmost pleasure write again.

TRANSLATE COPY OF A TÁKÍD

TO PUTTABI RÁMÁYYA Â'AMIL OF TRIPATTI.

Rajah Raghotum Row, a principal officer of the Nawab Asof Jah Bahadur, has lately proceeded from Haidrabad on a pilgrimage to Tripatti. On his arrival at Tripatti you will go and meet him on the outside of the suburbs, and receiving him with the highest distinction and respect perform the duties of Civility in the following manner viz<sup>t</sup>

1<sup>st</sup> All offerings of Dresses or Jewels which may be made by the said Rajah to the Deity, must be preserved in the Wardrobe of the pagoda dedicated to Balajee, and no person must prevent the Deity from being arrayed and decorated with the said dresses and Jewels.

2<sup>nd</sup> You must not appropriate any part of the offerings which may be made by the said Rajah to the Deity.

3<sup>d</sup> The said Rajah must not experience any kind of molestation or interruption in his devotional visits or in the festal ceremonies in Compliment to the Deity.

4<sup>th</sup> You must select and allot a Commodious and Suitable habitation for the said Rajah and his followers. It is likewise ordered that you do not demand any duty or Custom, either from the Rajah or any of his followers, but consider them totally exempted from the same and treat them with the most perfect politeness.

The Right Honourable Lord Clive has appointed and deputed Maisúr Tirmul Raw to attend the said Rajah; it is therefore necessary that you furnish the Rajah with all such articles as may be required for his use by the said Tirmul Raw.
