Doctor William Horsman, my second Physician, with whose regular attendance and his strict professional attention to myself and my family, I am perfectly satisfied, has heretofore been paid the Salary I allow him out of my Monthly Receipts from the Company, but as those Monthly receipts are inadequate to my current Expenses, I wish, as a matter of convenience to myself that his Salary should be paid from my surplus one fifth. I have therefore to request your Lordship will be pleased to direct that M^r. Horsman's Salary at the rate of Two hundred and fifty Star Pagodas per Month be paid, Monthly, from the 1st July 1803, at the Company's Treasury, in account of my surplus One fifth.

I have further to request that your Lordship will be pleased to order, the Monthly sum of Five hundred Rupees to be paid from the same period at the Company's Treasury to Kistnah Swamy a very old Servant of my late illustrious Grand father and who is now in my Service.

I shall also direct an allowance of five hundred Rupees per Month to be paid from the 1st of July last to Kistna Swamy, and shall give orders for adjusting the charge by a deduction from your Highness's proportion of the Revenues of the Carnatic, at the termination of the fusly year, agreeably to the application stated in your Highness's letter.

FROM PURNAYIA DIVAN TO THE RAJAH OF MAISUR

After usual Compliments

I was highly honored by the receipt of your Lordship's gracious letter, acquainting me of the appointment of M^r Webbe as Resident on the part of the British Government at the Court of His Highness the Maha Rajah, and I derived equal honor and gratification from the intelligence. M^r Webbe arrived in good health at Hurrihur. His Highness the Rajah as well as the Rani, and all their dependents derive much Satisfaction from this Circumstance, and are very grateful for the nomination of so distinguished a Gentleman to conduct the affairs of this Court.

Devoted as I am to the Honorable Company, considering it my duty and my pride to execute their orders, which I endeavour to do with Zeal and fidelity; I shall consequently discharge the duties incumbent on me, as they relate to both the Sirkars agreeably to the advice of the Resident.

In a late arzi I had the honor to acquaint your Lordship that, I had collected a body of one thousand horse which were encamped on the farther side of the Tungbhadra river with the intention of sending them to join the army.

As soon as your Lordship's orders upon this subject were received by M^r Webbe, he communicated them to me and proceeded along with me to view the horses, each of which he examined—when mustered there were 1045 choice horses fit for the Service of Government—these horses, with a battalion of infantry, 50,000 Star Pagodas received from M^r Webbe to be dispatched to General Wellesley, and 100,000 Star Pagodas for the troops of His Highness the Maha Rajah were sent off to the Victorious army on the 15th December—as they have a march so distant that it will be a month ere they can reach the Army, I have advanced them their full Pay to the end of december, besides 10,000 Pagodas for their expenses on the road. I

have received accounts of their arrival on the banks of the Krishna river— they travel rapidly—would have arrived at Puna in ten days from the place of their encampment at that river, and thence proceeded to the army.

Mr. Webbe and myself with the troops are on the confines.

May the Sun of your Lordship's
life and prosperity be resplendent.

TRANSLATION OF A LETTER

FROM RAJAH VIZIYA RAGHONATH TONDIMAN

TO THE RIGHT HONORABLE LORD WILLIAM BENTINCK &^{CA} &^{CA} &^{CA}

RECEIVED 9TH JANUARY 1804

After Compliments as usual—

Your Lordship's gracious letter in answer to my humble address having arrived conferred upon me honor and dignity.

In this letter your Lordship observed that the flattering marks of distinction which had been shewn to me, during the administration of Lord Clive Bahader, afforded satisfaction to your Lordship's mind. About seven months ago, my Lord Clive wrote to Mr. William Blackburn to ascertain my wishes with regard to some mark of the Company's favour: the aforesaid Gentleman having accordingly inquired of me, I informed him that, my first wish was, that all the countries of Hind and the Carnatic and even the Throne of Dehli should be subjected to the possession of the Honorable Company: and my next wish was, to obtain from the Honorable Company the Fort and Taluk of Killenly, the Title of Mahah Rajah, a white Chatter and a Golden Staff, which latter are the insignia attached to the Rank of Carnatic Rajahs: I was in continual expectation to hear the news of the Victory over Delhi and Hind: my desires and wishes in this respect have been happily accomplished. I also trust that my request, as above stated, may be accorded by the Honorable Company.

From your Lordship's greatness and generosity I hope that, the Title of maha Rajah, together with the white Chatten the Golden Staff and the Country of Killanelly may be bestowed upon me by your Lordship.

The accustomed Peshcush and Nazaranah from the Rajah of Travancore for the Fusly year 1212 which ended on the 13th July 1803 are due to me as the Sovereign of the Carnatic. I have therefore to request that your Lordship will be pleased to issue orders for the amount being paid to me.

I have also to inform your Lordship that, with the amount of Peshcush the Rajah annually sent an Elephant suitable to the personal use of the Sovereign of the Carnatic but, for the last three years, the Elephants have not arrived—on this Subject I trust your Lordship will also be pleased to give orders.

Your Highness will observe that the Resident has taken measures for obtaining the Customary present of Elephants due by the Government of Travancore.

TO HIS HIGHNESS THE NABOB AZEEM UL DOWLAH BAHADUR &^{ca} &^{ca} &^{ca} &^{ca} &^{ca}

May it please your Highness !

1. I have the honor to acknowledge Your Highness's letters informing me of the death of Seyf Ul Mulk, and Cawn Jehan, Cawn and requesting that the Stipends enjoyed by those persons should be paid to their Families.

2. Your Highness has also Solicited the Continuance of the pension received by the late Ali Hussein to his Widow the Enagut Begum, as well as the payment of the Sum allotted to Gassaty Begum in the original Pension list.

3. Your Highness I am confident will do me the Justice to believe that the delay of my answer to these several Applications has arisen neither from Inattention to the Wishes of Your Highness, nor from any unwillingness to concur in the humane and liberal sentiments of the former Government.

4. The consideration of the question involved a variety of points not in my power to determine, and which rested in a great measure upon an exact Knowledge of the Principles by which that part of the Treaty relating to the maintenance of the families of the Nabobs Wallajah and Omdut ul Omrah was regulated.

5. Not having been personally concerned in the formation of that Treaty it became necessary for me to examine the transaction in all its views.

6. It appears that the Nabob Omdut ul Omrah by a violation of the Sacred compact existing between the two Governments had placed the Carnatic in the light of an enemy to the Honorable Company, with the right existed also the power on the part of the British Nation of imposing its own conditions of Satisfaction. Unwilling to degrade the illustrious house of Arcot, the Government was pleased to establish your Highness upon the throne reserving to itself the administration of the Civil and Military affairs of the Country—a very considerable portion of the Revenue was appropriated to the Support of the rank and dignity of the Sovereign in his former Splendor, as well as to the no less princely purposes of extensive charity and benevolence. Upon the same principles of liberality the British Government undertook to provide a maintenance for the families of Waulajah and Omdut ul Omrah in the former case the amount and the time of payment have been fixed by Treaty. Uncertainty either in the one or in the other, would have frustrated much of the good

that may be so generally diffused from the wise distribution of so large a revenue—in the latter case the Specific amount was as wisely left undefined for it is necessary for various reasons that the present possess [*Sic*] as well as all those who may enjoy these stipends hereafter, Should look upon this allowance as depending upon the will of the donors only, and subject to total or partial reduction whenever it may be deemed expedient so to do.

7th It is evident that such modifications will be made necessary by various contingencies for want of respect to their legitimate Sovereign—Removes of relationship from the head of the family. Failure of male issue Decrease in the Numbers of each family—and by other causes.

8th My opinion upon this Subject will be made more clear by a separate examination of the lists of the families which your Highness has had the goodness to give to me, and by a consideration of the claims of the respective Individuals.

9. It is necessary for me to remark here, that in the distribution of a Stipend among the Subordinate Members; it will be always adviseable to Keep in view some broad principle of acknowledged law, In the present case, as the Stipend depends entirely upon pleasure, such reference might appear unnecessary, but as the law of Succession is the result of the united wisdom of our ancestors, it is entitled to all our respect and upon all questions of Individual claims the law of inheritance as established by the Mahomedon law, will be the best and most Satisfactory guide.

10. I will now review the family of Syful Mulk and the distribution of his pension as recommended by your Highness.

11. It appears to me that the Stipends allotted to Syful Mulk, Hessam ul Mulk and Nússeer ul Mulk ought not wholly to be continued to the family—their Successors more distant in their Relationship to the Sovereign, would not be warranted in the same display of rank and state which belong to the more immediate branches of the throne, the Eldest Son of Seyful Mulk however having been at one period next in lineal succession to your Highness, I feel averse to the diminution of the Stipend.

12th Your Highness proposed that the Stipend should be left to Your own allotment Notwithstanding the perfect reliance which I feel in the impartiality and justice of your Highness, it would not become the British Government in the State of its responsibility to those families by Treaty, and in the attention which it Acknowledges to pay to every other branch of its duty, to deligate entirely this very important part of its trust.

13. I also think that the Subdivision of a Stipend into Separate payments to the different individuals composing a family which I had the honor of proposing to your Highness equally liable to objection.

14th By the custom and law of all Nations, the head of the family is the natural Guardian of all the Subordinate Members—by the Mahomedan law that doctrine is particularly inculcated. I should therefore recommend that the whole of the Stipend enjoyed by Syful Mulk shall be paid to Seyful Dowlah his eldest son.

15. But as the engagement on the part of the Government is of a nature too Serious to permit an implicit reliance on the good intentions of any individual by which the execution of that article of the Treaty might in fact become precarious, I propose that in all cases the head of the family shall in communication with your Highness, fix upon the allotment, proper to be made to the inferior branches of the family; when this division shall have been made, I shall request your Highness to have the goodness to forward it to me, for the purpose of being Submitted to the final determination of this Government; by this arrangement the respect of the Subordinate Members of the family will be preserved to your Highness, the good faith of the Company to those Individuals will be guaranteed, and the Justice of heads of families towards their numerous dependants will be Secured by the constant Superintendance of your Highness's paternal care and affection.

16th I have the honor to inclose the Copy of a letter which I intend to address to Seyful dowlah upon this Subject.

17th I fell [*Sic*] myself obliged to observe that the general Appropriation if [*Sic*] this pension appears to have been decided by no principle of Mahomedon law.

18. Seyful Mulk is represented to have died very much in debt. The Stipend can only be considered as a life annuity not disposeable in any part of its amount by the possessor after his death. I feel myself under the necessity of declaring my opinion most positively that no pension hereafter can be made liable to the debts of the former holder: this is but an act of common Justice to the family in general; were such a practice permitted, the benevolent intentions of Government would be entirely frustrated and all the collateral branches would be reduced to beggary and distress. I therefore request that your Highness will be so good as to make this determination Known to all the persons holding pensions and where such debts may have been already contracted. I shall rely upon the attention of your Highness to the honor of your family for suggesting such arrangements as may put those debts in a State of immediate liquidation during the lives of the present incumbents.

19. Cawn Sehaun Cawn having left no legitimate issue, I propose that his Widow shall receive $\frac{1}{4}$ th of his Stipend agreeable to the Mahomedan law, the sums appropriated for the maintenance of the Natural children do not appear objectionable.

20. I am under the necessity of not entirely concurring with your Highness in the proposed division of the Pension of the late Ali Hussein, it appears that he has left a widow without any issue. Her Share of the Pension is 500 Rupees, an adopted daughter and four Ladies attendant upon the Widow compose the family—none of these individuals are entitled legally to inherit, and I am of opinion that they ought not to appear included as Members of the family. I do not feel myself at liberty to consent to any Sum and much less to so large a Sum at 500 Rupees per mensem being expended for the fatihal of the deceased—this mode of appropriation would be an entire departure from the principle of life Annuity, in which light these Stipends can alone be considered. The Fatihah I understand to be the duty of each of the family, and to be performed by each in the manner that may accord with his circumstances.

21. As a degree of inconvenience might be felt by too rigid an adherence to the law however just, I should propose in this instance that 1200 Rupees be paid to Enayut Begum for the total expense of the family.

22. The Stipend of Gussalty having already been fixed it is only necessary for me to enquire from your Highness the date of her Submission to your Highness's Authority, in order that directions may be issued to the Treasury accordingly.

Para 1. I have received with great concern from his Highness the Nabob, information of the Death of your much honored Father, Seyful Mulk.

2. His Highness influenced by that kind regard which he feels for the happiness of all his relations has urgently requested the continuance of the pension to his Family.

3. I have had the honor of expressing to his Highness, the pleasure with which this Government will comply with his request, and I have also informed his Highness, that directions will be given to the Treasury that the whole of the Stipend shall be paid into your hands.

4. You are now the representative of your deceased Father. You are become the parent, and natural Guardian, of the Family and I am satisfied, that under your sole Care, the wants and Comforts of every individual belonging to it, would have been affectionately provided for. But the British Government has engaged by a solemn Compact to maintain the Families of Wallajah, and Omdut ul Omrah. By the nature of this engagement their charge extends, to every individual of the Family, to the last, as well as to the first. It is therefore an obligation upon the Government to know that each person receives a maintenance, and it will therefore be necessary that the amount to be paid to each should be exactly specified. The Government will then feel that it has conscientiously discharged its duty to all. As you are the guardian of a subordinate branch, of the illustrious family of Arcot So his Highness is the legitimate Sovereign, and Parent of the whole.

5. I am happy in being able to assure you, that upon all occasions, I have observed in his Highness, one uniform interest for the welfare of his Subjects, and I trust that no individual will be wanting in their allegiance and in a return of grateful Affection. Acting upon these principles it is my request that you will without delay, lay before his Highness, a list of your Family, and that with the assistance of his advice, and counsel, you will make such a distribution of the Stipend, as may afford a proper degree of independance, to the head, consistently with a comfortable subsistence for the subordinate members of the Family.

6. I have requested his Highness to [*Sic*] to transmit for the final decision of this Government, a list of your Family, and the proposed appropriation of the Stipend.

I accordingly procured a Copy of the Will written by the said Khan some time previously to his demise, whence it appeared that he left an only Son named Mahomed Baker Hussein now only three years old to be his sole heir, to remain during his Minority, till he attain the age of twenty one years under the guardian Ship of the uterine Brother of the deceased Viz^t Hafiz Ihmed Khan, the sole executor, who is directed to manage affairs, if the Jagir be restored, or if the allowance be continued to distribute it according to a list annexed.

The said deceased not having Specified any Monthly Salary for his said Son, it should seem to have been his intention that after defraying the expences of the nuptial Ceremonies of his Daughters and liquidating the debts which he owed, the remainder of the Money should be retained in deposite for the benefit of the boy.

This arrangement appearing to me to be proper, I trust that it will also meet your Lordship's Approbation.

General Wellesley having suggested to Major Wilks the expediency, if it were practicable, of leaving the troops at Hurrihur, and proceeding on a tour of the districts; wherefore the whole of the troops having been left at Hurrihur, Major Wilks and myself departing thence, visited Several Taluks and repaired by the route of Sera and Chittledroog to Maisur. Under your Lordship's happy auspices, the population and prosperity of the Country increases, the settlement and Collection of the revenue proceeds in the happiest manner and the Inhabitants are employed in their respective occupations with cheerful industry: these circumstances will have been made Known to your Lordship by the Addresses of Major Wilks.

The Maha Rajah's troops serring [*Sic*] with the Victorious Army are at present, by order of Major General Wellesley, posted in Zilla "Punderpore and the General himself is at Puna.

Having learnt that it was not improbable that the General should hereafter renew hostilities, I deemed it to be prudent to send to the troops of the Maha Rajah 1,20,000 Haideri, and 20,000 Kanterri Pagodas, with an escort of a batallion of Infantry under an experienced Officer—having arrived under his command at Hurrihur, they proceeded on the 20th June towards the Army:—the Zeal and devotion of the Cavalry will have been represented to your Lordship by the General, and he will continue to represent the same.

Major Wilks and myself on our arrival here, having surveyed the new bridge constructing in the name of the Governor General, observed what had been executed and what remained undone—after causing the necessary materials to be procured and giving the most express and positive injunctions about the work, it is now finished, except a small part of the parapet, which in a month or Six Weeks will also be accomplished—the river being now three fourths full, a passage is afforded for Men, Merchendize, Grain and other articles—the passage by boats is suspended, and the people with satisfaction and gratitude acknowledge the utility of the Lord's Bridge—it is constructed in the strongest manner, calculated to endure for ages without decay—it is thro' the auspicious destinies of its great patron that it hath been executed with this degree of expedition and permanency.

A severe scarcity and famine prevailing in the Districts north of the Krishna and Tungbudra rivers, the Inhabitants of these provinces have, in consequence, repaired in great numbers to Maisur—from 1000 to 500 of them are now in each Taluk and they Still continue to come in—they are furnished with grain in this Country:—nevertheless—by the good fortune of your Lordship, abundance reigns here, and nothing is scarce.

Owing to the scarcity which prevails in the Army, the Horses are become lean and Weak. I send for those of this description by lotts, replace them by others in good condition from Harrihur—where the lean and weak recruit again, and are again dispatched. I endeavour, by every means in my power, that the horses with the General shall be capable of duty—the troopers families left in Maisur have family Certificates, according to which they receive their Monthly subsistence, and are comfortable. The families of the troops at Harrihur receive their Monthly subsistence in like manner and are contented and happy—all possible indulgence is shewn to the troops, with a view to stimulate them to active exertion for the public weal.

These circumstances your Lordship will learn from the communications of Major Wilks.

May the Sun of your Lordship's Life and prosperity be resplendent!

In tracing the cause of such effects, they cannot fail to afford satisfactory evidence of unremitting Zeal and vigilance in the internal administration of the affairs of Mysoor; and I look forward with a degree of pleasure proportioned to my confidence in your qualifications for the trust reposed in you, to the progressive augmentation of the wealth and happiness of that Country.

I am happy to learn that you continue to direct your attention to works of public utility and magnificence; and I consider it to be a proof of the expansion of your mind, that you study to promote such undertakings as are equally Calculated to augment the productive powers of the country, to exalt the honor of the Government of Mysoor, and to distinguish the era of your administration.

Garrow and Major Macleod having ascertained the fact of this established usage, issued Dustucks for the exemption of duties on Fruit &^{ca} and on horse Gram purchased and brought into Arcot for the feeding of my Horses and this ancient usage, continued to be observed until the expiration of the last Fuslee year.

Since the commencement of the present Year 1214 Fuslee, Major Macleod, demands payment of the Duties and states that he cannot forego them, without orders from the Board of Revenue.

I have therefore to Request that your Lordship would be pleased to issue orders for the usual exemption of duties upon the Fruit &^{ca} of the said Gardens and upon Gram for the consumption of my Horses.

2. Your Highness having also made mention of articles of produce intended for sale I beg leave to observe that under the Regulations which have been lately established for the collection of duties in the territories under this Presidency such an exemption would be liable to produce much public inconvenience and as I am satisfied that the object cannot be material to your Highness I feel confident that your Highness will be disposed under the Suggestion which I have stated to relax that part of your request, with which it would not be practicable for me to comply without a departure from the principle of the Regulations to which I have referred.

DIVAN TO THE RAJAH OF MAISUR

TO THE RIGHT HONORABLE LORD WILLIAM CAVENDISH BENTINCK

DATED 18th AUGUST

1804.

RECEIVED 27th D^o.

General Wellesley having returned from the Campaign [*Sic*] to Seringapatam with victory and health, I had the honor of visiting him : before this time he will have arrived at Madras.

When the General left Puna, he gave Bishtu Pundit Bukshi permission to return with the troops: the Bukshi has Accordingly arrived in Maisur with 3200 Cavalry—and Khan Jehan Khan, Bukshi, has also arrived in maisur, from Hurrihur, where he had been detached with a body of infantry and 1,000 Cavalry and whence I had recalled him, by permission of General Wellesley.

The said Cavalry amounting to 4200, with their dependants and families, have received their allowances in full, and an advance of two Months pay: the horses have been sent into the different talooks to pasture.

As these Cavalry had exerted themselves Zealously and gallantly, throughout the Campaign; and as Bishtu Pundit Bukshi had so pledged himself to them; the pay of some was encreased—golden bracelets, necklaces and dresses were presented to the Risaladars, Jummudars, Duffadars respectively—and, among the troopers, generally, according to the good conduct of each, from three to twenty rupees were given as presents—the whole disbursement distributed in this Manner, as a gratuity Amounted to the sum of 200,000 Rupees: intelligence to this effect will have been communicated to your Lordship by Captain Wilks.

To those Men who had lost their horses in the war, the Bukshi advanced money, to remount them—thereby ensuring their Service—the money thus lent them has been remitted. the expenses incurred by the Bukshi, the muttesuddies and officers, during the Campaign, having been ascertained, has been paid by the Sirkar—and, besides this, Complimentary presents have been made to each of these officers:—In short, to every individual who exerted himself Zealously in the late Campaign under the General of the British Government, from the trooper to the Commander of the Maha Rajah's forces, some token of favour and distinction has been given, flattering to each, and all acknowledge themselves to be gratified and happy.

Subsequently to the departure of the General, and to the return of the Honorable Company's, and the Maha Rajah's troops, Multitudes of the inhabitants of the districts situated on the Northern banks of the Kristna and Tungbudra Rivers, under the pressure of famine, have resorted to this Country—the Beoparies also repair hither, and having purchased Grain, Carry it away for sale:—hence much of the Grain of Maisur has been consumed—May the sun of your Lordship's life and prosperity be long Resplendent in the horizon of Magnificence and Glory.

Captain Mahony having been appointed envoy on the part of His Excellency the most noble the Marquis Wellesley lately arrived here and delivered to me a Letter from His Excellency: Captain Mahony at the same time acquainted me that, in conformity with the directions of the Governor General, it was your Lordship's intention to order an addition of territory to be made to my Country.

Agreeably to the suggestion of Captain Mahony I deputed Kurrung Subayia one of my dependants to proceed to Mangalore thro' the Channel of Captain Mahony: Kurrung Subayia having accordingly gone to Mangalore, visited M^r. Ravenshaw by whom he was received in a very respectful Manner: having remained there for some days, received the accounts, and adjusted the affairs of the territory which has been transferred to me, he took his departure on the 13th August agreeably to the desire of M^r. Ravenshaw, and on the 15th arrived at the taluk of

Puttur on that day M^r Ravenshaw caused an advertisement to be issued on the part of the Honorable Company promulgating to the Inhabitants the transfer to my authority of that part of the territory of Mangalore.

It is impossible for me sufficiently to express my grateful sense of this favour, may the Almighty continue to increase the power and prosperity of the Honorable Company enabling them to gratify the wishes of a whole world.

I have been also informed by Captain Mahony that your Lordship had been pleased to direct that the revenues of the last year, which had been derived from this new territory should likewise be relinquished to me.

The issue of such a generous order, without any overture on my part for the purpose, I consider as a mark of distinguished favour. I infer from it that from the day I was so happy as to repose in the shade of the Company's protecting Banners, my alligiance and Services have happily been approved and the honor thus conferred upon me results from the beneficence of the Honorable Company.

I declare seriously that in attempting to perform the duties of allegiance and Service to the Honorable Company, whatever I have done without consulting Captain Mahony has been unwise and injudicious—but, whatever I have executed by his advice and Approbation, has been applauded.

By the blessing of God and under the auspices of the Honorable Company, my prosperity is likely to improve daily.

May the Almighty long preserve your Lordship in the Government of Madras with these favorable dispositions towards your Zealous dependants.

exhilarated the heart of hope. It is indeed true that I have in this world no other patron than your Lordship — and I am firmly persuaded that your Lordship will protect me and my posterity, and honor us with your favor and indulgence, in such manner as we would wish.

Several of the Members of my Family who have all along manifested the most inveterate aversion towards me, having lately Signified their wishes to retire from my Garden of Chepauck received permission from me to do so.

In consequence of such permission Hussam ul Mulk, Sultan ul nissa Begum, Mulk ul Nissa Begum, Mahomed Nauser Cawn with their families and several others, their adherents have quitted the Garden of Chepauck.

My Friend.—It is not unknown to your Lordship how much I have suffered from the turbulent and refractory conduct of these people ever Since my elevation to the musnud of my Ancestors. Every effort that malice or perversness could suggest, they have made use of to Asperse my Character, disturb my comfort, and embarrass my Affairs:—whilst my conduct towards them has been marked throughout by lenity and moderation, and I have left no exertion untried to conciliate their affections.

Finding all my attempts to reconcile them to me to be unavailing that their enmity was implacable and that they were determined on a system of unceasing annoyance, — with the Approbation and concurrence of my friends the English Government, I twice Comanded them, many months ago, to withdraw from my Garden, but they refused to do so under frivolous pretences and now that they have retired /most probably under the influence of interested Advisers/ they have not only carried away with them all the property belonging to my Grandfather, my Father and my Uncle which had fallen into their possession, together with the Seals, Firmauns, Sanuds and other Regalia but in the Violence of their animosity and intemperace, they have proceeded to Such a length as to raze the very buildings wherein they resided : buildings which had been given them by the Nabob Walajah /who rests in paradise/ only as a residence, — which formed a part of the Palace of Chepauck, and having been Mortgaged by the late Nabob Omdat ul Omra to M^r Francis Lautour, were redeemed by me, through the medium of the English Government, after my elevation to the musnud.

If, my friend, the conduct of these people has been of this nature whilst residing within the precincts of my Palace and under my own immediate inspection—what may they not attempt now that they are liberated from all restraint and have free and direct communication with that description of Men whose interest it is to

mislead them, who profit by the folly, the vices and the Misfortunes of others, and who have no doubt advised them to withdraw themselves from my protection, that they may be fleeced with the greater facility?

That these misguided people will propagate many falsehoods and do every thing they can to injure and calumniate me, is what I am naturally to expect. I know they are capable of any thing. I have already apprised your Lordship of their being provided with a quantity of Sepoy Cloathing and a number of Firelocks, and their intention of entertaining the Caffree Company of Sepoys whom I had recently dismissed from my Service for Seditious practices. I shall leave to your Lordship to judge of the propriety of their Actions, the purity of their Intentions and the degree of Credit that is due to any Allegations they may make—trusting that your Lordship and the world will acknowledge my timeperance and forbearance in suffering the dilapidation of the appendages of my Palace without manifesting that degree of resentment which so unjustifiable an act would have warranted.

The above audacious act of those Members of my family has been aggravated by the mean and reprehensible manner in which they quitted my Garden without the usual formality of taking leave.

I deemed it necessary to state these particulars for your Lordship's information.

TO THE RIGHT HONORABLE LORD WILLIAM BENTINCK

GOVERNOR OF MADRAS WITHOUT DATE RECEIVED DEC^R 1804.

After Compliments

An intercourse of amity and Alliance having always subsisted between the Offaman state and the British Government hence the Governors and Rulers of each should mutually cultivate the relations of friendship and Concord.

Under this impression, entrusted as I am with the dominion of this region and deeming it to be my duty to imitate the example of my predecessors by maintaining a Correspondence with approved friends, such As the Generalissimo of the Soubah of Bengal and other Governors of these provinces; I have deputed His Excellency the trusty Seliman agha of Inderan as my Envoy, with letters to the respective Governors dependent on Bengal.

Now as it is most likely that the said Envoy will have occasion to travel thro' the provinces under your /Lordship's/ Administration, I considered it incumbent on me to transmit by him this letter as a token of my friendship.

I request that your Lordship would give orders for facilitating the journey of the Envoy through your Lordship's territory, and for assisting him in his return hither comfortably—and I also hope that, by means of people travelling this way, you will signify to me the news of that quarter with your Commands in this, and with Gods assistance they shall be executed.

May the days of your prosperity

Be according to your desire !
